I, the undersigned,

MOSHE ASHIRIE

hereby make oath and state:



1. I am an adult, male employed by the Jewish Agency for Israel ("JAFI") as chief financial officer. My business address is King George 48, Jerusalem, Israel.
2. The facts contained in this affidavit fall within my personal knowledge. All the facts herein are true and correct.
3. I derive my knowledge from the position I hold within the organization. I am involved in all the functions of the organization discussed in this matter.
4. I have read the affidavits of PHILIP KRAWITZ deposed to in this matter and the confirm the correctness thereof, to the best of my knowledge, insofar as they relate to JAFI.
5. In addition thereto, I provide the following background facts relevant to the issues raised in this application.

THE WORK OF JAFI

6. JAFI's work falls under five broad areas, in Israel and around the Jewish World:

- 6.1. "Aliyah" or immigration of Jews to Israel.
- 6.2. "Resilience & Connection" focusing on safety of and connecting Jewish communities around the world.
- 6.3. "Relief & support" to civilians impacted by conflict in Israel.
- 6.4. Education about Israel and Jewish identity in communities around the world.



6.5. Jewish education as part of the formal and informal education systems in Israel.

7. The JAFI is recognised as one of Israel's "national institutions". However, it operates independently from the government of Israel.
8. I confirm that JAFI does not provide any funding whatsoever for the government of Israel or the Israeli Defence Force.
9. JAFI predominantly raises project-specific funds. Donors are explicitly asked what he or she is donating the money for and funds are earmarked for that project.
10. Two specific programmes are discussed in this matter, being the Fund for Victims of Terror and the immigration/settlement programmes.
11. I confirm that Mr Krawitz has only been involved in fundraising for the following two programmes:
 - 11.1. The Fund for Victims of Terror, that provides mainly Long-term rehabilitative assistance, as well as a first responder services that provides short-term financial stipends within 48 hours, to terror victims of all backgrounds, as set forth below.
 - 11.2. The Youth Futures program. This programme provides educational and mentoring programs for at-risk Arab adolescents, among others in different cities in Israel. Most of these donations were used in in the Muslim-Jewish city of Lod.

12. I confirm what Mr Krawitz stated about the Fund for Victims of Terror. The Fund provides rehabilitative assistance to any person who has been harmed in a terrorist incident in Israel and who is lawfully present in the country, including: Jewish, Muslim, Christian, Druze, and Circassian citizens; residents; tourists; migrant workers; and Palestinian workers holding valid work permits. The Fund provides assistance exclusively to civilians and does not extend assistance to members of the security forces – soldiers, police officers, and other members of the security forces.
13. With regard to the programmes facilitating Aliyah and support of olim (immigrants), JAFI provides, amongst others, absorption support.
14. JAFI does not fund, undertake, or support any settlement activities outside of the "Green Line", being the 1949 Armistice border.
15. In response to Para. 162 of the answering affidavit: Keren Hayesod is a 20% stake-holder in the Jewish Agency for Israel.
16. In response to Para. 165.1 of the answering affidavit: Garin Tzabar is not a programme of JAFI. JAFI provides its own absorption services for new immigrants (including housing in the early stages of immigration, Hebrew language classes, etc).
17. In response to Para. 165.3 of the answering affidavit: The Fund for Victims of Terror, has no representatives of the Ministry of Defence serving as members, and soldiers do not receive assistance from the Fund. The Fund includes representatives of the Social Security Institute.
