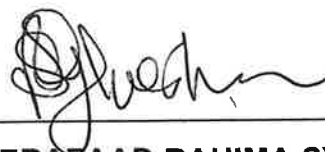

**FIFTH RESPONDENTS' ANSWERING AFFIDAVIT**

I, the undersigned,

**SAYED RIDHWAAN MOHAMED**

state under oath:




1. I am the fifth respondent.
2. The facts in this affidavit are true and correct. They are within my personal knowledge and belief. Where I rely on information from others, I state the source and believe the information to be correct. Where I make legal submissions, I do so on the advice of my legal representatives, whose advice I believe to be correct.
3. I have read the founding affidavit (**FA**) delivered on behalf of the first and second applicants (**Cape Union Mart** and **Mr Krawitz** respectively and the **applicants** collectively). I oppose the relief that they seek against me.
4. I have also read the answering affidavit of Usuf Chikte, delivered on behalf of the Seventh Respondent (**PSC**) and the second to fourth respondents (**PSC respondents** collectively). I adopt the overall defence in that affidavit, to the extent that it is relevant to me, my conduct and statements that I have expressed publicly.
5. I am not a member of the PSC. I am a member of the public, who used to attend pro-Palestinian protests, including those of the PSC. My participation is not an attack on Judaism or on Mr Krawitz on account of his faith.
6. I respond below to the paragraphs in the FA that refer to me. Where I do not specifically traverse an allegation directed at me, I respectfully ask that it be taken as denied, to the extent that it conflicts with this affidavit and the PSC respondents' affidavit.

7. Annexure "C43" to the founding affidavit is a screenshot of part of a post on my *Instagram* account. It shows my wife and me outside the Cape Union Mart store in Canal Walk.
8. The applicants claim that the photograph was taken on 31 May 2025, which is not the case. Screenshots of the full *Instagram* post reflects 18 November 2023 as the date of publication (attached as **SR1**).
9. Annexure "C43" shows my wife and me, holding two posters. We did not prepare the posters ourselves; a friend of ours (not a PSC member) did.
10. When we arrived at the protest at Canal Walk on 18 November 2023, we stood alongside some PSC members, whom we recognized.
11. Shortly after our arrival, a PSC marshal and Mr Chikte, asked us not to display photographs of Mr Krawitz. We put the posters away immediately, and continued to participate in the protest without displaying them further.
12. I have not used that poster since.
13. I nonetheless believe that the poster is justified expression on the grounds pleaded in Part G of the PSC respondents' answering affidavit, which I adopt.



**Involvement in PSC protest of 31 May 2025**

14. On 31 May 2025, I attended a protest outside Cape Union Mart at the Waterfront. Pro-Israeli protestors were holding a counter-protest.
15. One of the pro-Israeli protestors told me that they were there on the instruction of Martine Krawitz (Vogelman). They began to harass us; they threatened to *'burn [my] child in a tunnel.'*
16. At that point we left the protest and have not attended another since.

**Interdictory and mandatory relief sought is unsupportable**

17. Framed as against me personally, the interdict is impermissibly wide, includes prohibitions unrelated to anything I have done, and amounts to a prior restraint on speech.
18. I do not concede that anything I have done, properly construed, has harmed the applicants; and, in any event, I have stopped attending PSC protests.
19. I thus ask that the relief sought against me be refused with costs, including costs of two counsel on Scale C.

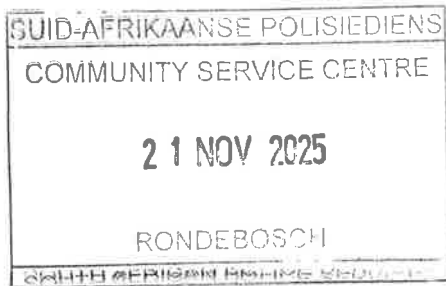
